Malkapur (Kohlapur), Maharashtra

1 City Profile

Malkapur is a class C Municipal Council (1922 feet above sea level) formed in 1884, with an area of 1.86 sq.Km, located 50 km northwest of Kolhapur, in Kolhapur district of Maharashtra, with a population of 5339 (Census 2011).








Figure 1: Access to type of sanitation facility in Malkapur

2 Sanitation Scenario in the city prior to the launch of mission

According to Census 2011, out of 1107 HH in the city 773 households had toilets on premises, 330 households are dependent on community toilets and 4 households defecate in open. Presently 80% toilets are connected to septic tank and the septage collected from these septic tanks is processed into compost by Malkapur Municipal Council (MMC).

3 Targets set by the council under SMMU

MCC decided to make the city open defecation free by shifting the HH defecating in open to community toilet or own toilet. Thus they worked towards improving and maintaining the condition of community toilets and also providing for new community toilet where ever required.

4 Initiatives by the council

4.1 City wide Household and Community toilet Surveys

A survey was carried out at city level, to identify households with and without individual toilet and to study the present condition of community toilets in the city. Based on which required measures were taken to repair and refurbish the toilets.

People in the city who didn't have individual toilet nor space for one, council built community toilets for them. Also the existing community toilets have been repaired and refurbished. The roads connecting community toilet were repaired. Water and electricity connection was provided to respective community toilet. The city has 17 community toilet blocks with 72 seats and 3 mobile toilet vehicles with 14 seats.

4.2 Awareness Generation measures

In order to implement the ODF scheme, door to door awareness campaign was carried out, where group discussions were conducted asking people not to defecate in open. Use of community toilet was promoted as an alternative to defecating in open. Also banner and hoardings were put at various spots in city. Along with that Auto rickshaw announcement were made all around the city asking people to opt for community toilet or build their own toilet and not to go for defecating in open. The health department formed a team that would go around the city in morning at various OD spots and thus stopping people from defecating in open and asking them to use community toilet.

4.3 Participation of Social Organizations and Citizens

Under SBM the city council had organized an event called 'Run for Unity' on o2nd Oct 2014. The event was attended by the council staff, councillors and the citizen of Malkapur, where they all took the oath of keeping the city clean and making it an open defecation free city.

In order to support the same cleanup drive was carried out on 8th August'14 in schools and college where the students, teachers, the council staff, parents and citizen participated actively.

Also on 15th August'14, 2nd Oct'14, 26th Jan'15, rallies were organised with the help of council staff and school students to create awareness about cleaning the city and preventing open defecation.

4.4 Efficient Maintenance of the Community and Public Toilets

The city has 17 community toilet blocks with 72 seats and 3 mobile toilet vehicles with 14 seats. Also roads connecting community toilet were repaired. Water and electricity connection was provided to respective community toilet.

In order to monitor the maintenance of community and public toilet along with the drains, the city has provided a toll free number 1800-233-2938, for citizens to register their complaints regarding poor maintenance of drains or toilets.

4.5 Monitoring of likely Open Defecation (OD) spots to prevent OD

The health department has formed a team that would go around the city conducting surprise visits in morning at various OD spots and thus stopping people from defecating in open and asking them to use community toilet. Two major areas have been identified as OD spots. Off which one spot have been cleaned and paved with paver blocks. While for the other spot a landscaping plan and community toilet has been proposed. Mean while these areas and other likely spots are being regularly visited by the OD monitoring team to keep check.

Pamphlets were also distributed to people who were observed to be going for OD and other individuals who don't have own toilet, asking them not resort to OD, instead use public/community toilet or build their own toilet and use the same.

5 Declaration and Validation of ODF City by the Government

On 15th September 2015, PMC declared Malkapur as an ODF city and submitted a report to the Government of Maharashtra (GoM). On site validation at district level was done by the collector office, Kohlapur on 30th September 2015 and positive report was submitted to the GoM. On 2nd October 2015, MMC was awarded by the Hon. Chief Minister of Maharashtra during the State level event organised by the GoM. Further, on 17th, 18th, 19th December 2015,

State Level Validation Committee conducted an in-depth validation as per the process set and the checklist provided by the GoM. MMC passed both this validation stage and is now listed as an "ODF City" in Maharashtra.

6 Strategy for Moving towards ODF+ / ODF++

As a sanitation improvement strategy for the city, MMC has decided to address sanitation value chain, and to begin with they are starting with construction of IHHL. They wish to plan and work accordingly to satisfy all three indicators of "ODF++ cities" of the framework developed by the GoM for defining ODF Cities in Maharashtra, which are as follows:

Malkapur has already achieved the first indicator of this framework by eliminating open defecation practices in the city.

To achieve the ODF+ status, Malkapur is making efforts to achieve own toilet coverage of >80% by ongoing toilet construction activity under SBM. The city is planning to prepare septage management plan, which covers the various components like regular septic tank emptying services, safe collection and treatment of collected faecal waste.
